About this website

This personal website is maintained by Ray Collett, hon secretary of Worcester City Chess Club and hon assistant secretary of Worcestershire Chess Association. The website is not controlled by Worcestershire Chess Association, Worcester & District Chess League, Worcester & District Chess League, Dudley & District Chess League, or Worcester City Chess Club.

Purpose of website

The website is intended to publicise chess organised in and around Worcestershire, facilitate team and individual chess competitions organised by the chess organisations identified above and to record results of team matches and games in individual competitions.

Permissions to publish contact information of club secretaries, chess team captains, officials of Worcestershire Chess Association and officials of Worcester City Chess Club

I am committed to protecting and respecting your privacy. I believe I have received explicit permission to show contact details of secretaries of chess clubs, team captains, and officials of Worcestershire Chess Association and Worcester City Chess Club as published on my website.

This policy explains when, how, and why I collect your personal data.

How I collect your information

The only information I obtain about you was provided directly by you or by an official or captain of your chess club. If I received information from you or a club official or team captain I believe I have asked you for permission to publish it on my website. I do not collect personal data simply as a result of you visiting my website.

How your information is used

The personal data I obtain is applied for the following purposes, namely to:

- > Facilitate contact between members of the public and honorary secretaries of chess organisations named above.
- Facilitate communication between officials of chess organisations principally for arranging matches between teams in the three leagues that feature on this site.
- Facilitate communications between members of the chess clubs, leagues and organisations that feature on my website.
- Facilitate Worcester Chess Association grading officer's submissions of the results of league and club games to the ECF for grading purposes.

Consistently with this, the contact details provided to me by club secretaries or team captains may be used to contact them by mail, telephone, fax or e-mail for the purposes of the chess organisations named above.

I will hold personal data for as long as a person is a captain or official and for a reasonable time afterwards.

This data is held pursuant to the legitimate interests of the above named chess organisations which is the basis on which your data as set out is processed.

Who can access information

Unless required by law, I do not sell, rent or otherwise share personal data with other third parties.

Rights

You can ask for a copy of the data I hold about you.

- > You can request that I correct mistakes
- > You can request me to remove personal information about yourself from the website
- > Should you have any unresolved complaints about the way I process your personal data, you have the right to make a formal complaint to the Information Commissioner's Office (ICO).
