Treasurer's Report to Annual General Meeting 26th May 2017

Association Accounts 2016-17 The accounts have been approved by our Auditor, Stewart Fishburne. The signed original is with the Secretary. My thanks go to Stewart for his support and timely auditing of our accounts and to our match captains and officials for their clarity and co-operation in dealing with financial matters.

We have realised a surplus on our current account this FY and review of accruals from 2015-16 shows that we made a surplus in that year as well. Our Vice-Presidents have, as ever, been very generous with their donations and provided over 25% of our income. We should recognise this contribution with our thanks.

I draw attention to the reduced cost of County Matches in 2016-17. This reduction in cost is a consequence of the small number of home/neutral matches and has been a major contribution to the surplus. Noting that all three teams had reached the KO stages, the Executive Committee agreed that we should have a without-precedent board fee 'holiday' for the KO stages. This will impact our 2017-18 budget, but I believe it is an appropriate use of our funds.

We transferred £1000 to the NS&I account in FY 2016-17 and have subsequently transferred a further £300. The balance in the NS&I account is £1892.32.

ECF Membership Following some issues over ECF Game Fees this year, I urge players who join the ECF to check they are on the database and to document any related discussions with the ECF.

On-line access to our current account In line with the decision of the Executive Committee, I have applied for on-line access to our account for myself only. Dr Ray Collett as our alternate signatory will be able to conduct Association business by conventional means.

Arrangements for 2017-18 I recommend that our fees remain unaltered; Affiliation Fee £5.00, League Entry Fee £19 per team, KO Cup Entry £3.00 and County Match board fee £2.00. An outline budget is provided below. Many of our costs are difficult to estimate with any accuracy, but I draw attention to:

- A projected loss on County Matches (attributable in part to our board fee holiday for the KO stages) and an estimated small loss overall on our current account. I do not believe that this is a matter for concern since we have realised a surplus on core operations since 2012-13.
- Purchase of extra plinth or a supplementary shield for the Div 1 trophy. Since this is a one-off item, I recommend that we take this cost against £200 which I had proposed to transfer to our reserves.
